

RESOLUTION NO. 2013-26

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BELL ADOPTING
THE 2013-14 BUDGET**

The City Council of the City of Bell resolves as follows:

SECTION 1: The City Council finds and declares as follows:

The City held community forums on April 27 and April 30, a City Council budget workshop on May 16, a regular City Council meeting on June 5, and a City Council public hearing on June 19 to review, consider, and deliberate upon the proposed 2013-14 Budget.

SECTION 2: The City Council adopts Budget for 2013-14. The budget for 2013-14 as shown in Exhibit A is hereby adopted.

SECTION 3: Appropriation for 2013-14. The amounts shown on Exhibit A which are necessary to fund the operating programs and the Capital Improvements Program for the City of Bell during 2013-14 are hereby appropriated from the unappropriated fund balances anticipated to be available on July 1, 2013, and from the estimated revenues and transfers in to be received during the fiscal year beginning July 1, 2013, and ending June 30, 2014.

SECTION 4: Authorized Interfund Transfers for 2013-14. The transfers from one fund to another as shown on Exhibit A for 2013-14 are hereby authorized.

SECTION 5: City of Bell Budget Authority. The City Council authority of the adopted budget shall be for the City as a whole and it is hereby mandated that any and all changes of appropriation at the fund level shall be subject to approval of the City Council.

SECTION 7: Administrative Budget Authority. It is hereby declared that, in addition to the City Council's level of authority, there is a need for a level of administrative authority over the adopted budget. The City Manager, therefore, shall have the administrative authority to approve appropriation transfers between expenditure line-item accounts as long as the total expenditure appropriation, by fund, remains unchanged.


SECTION 8: Effective Date. This Resolution shall take full force and effect on July 1, 2013, after its adoption by the City Council.
