

RESOLUTION NO. 2014-16

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BELL, CALIFORNIA DESIGNATING AND CONFIRMING EXISTING UNITS FOR CERTAIN REPRESENTED FULL-TIME AND PART-TIME OFFICERS AND EMPLOYEES OF THE CITY, AND RESCINDING RESOLUTION NO. 2012-68

WHEREAS, pursuant to Government Code Section 3507, the City Council of the City of Bell, after consultation in good faith with employees of the City, adopted Resolution No. 87-46, which provides rules and regulations for the administration of employer-employee relations;

WHEREAS, Section 9 of Resolution No. 87-46 authorizes the City to determine the appropriate unit for each employee classification;

WHEREAS, the City Council desires to designate appropriate units for certain employee classifications and confirm the existing appropriate units for employee classifications;

WHEREAS, the City Council also desires to affirm the existing exclusively recognized employee organization for each appropriate unit;

WHEREAS, the City Council adopted Resolution No. 2012-68 on September 19, 2012 regarding the designation and confirmation of certain represented employee classifications in appropriate units; and

WHEREAS, the City Council further desires to rescind Resolution No. 2012-68.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BELL DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. Resolution No. 2012-68 is hereby rescinded.




