

**RESOLUTION NO. 2016-19**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BELL, CALIFORNIA DESIGNATING AND CONFIRMING EXISTING UNITS FOR CERTAIN REPRESENTED FULL-TIME AND PART-TIME OFFICERS AND EMPLOYEES OF THE CITY, AND RESCINDING RESOLUTION NO. 2015-10**

**WHEREAS**, pursuant to Government Code Section 3507, the City Council of the City of Bell, after consultation in good faith with employees of the City, adopted Resolution No. 87-46, which provides rules and regulations for the administration of employer-employee relations; and

**WHEREAS**, Section 9 of Resolution No. 87-46 authorizes the City to determine the appropriate unit for each employee classification; and

**WHEREAS**, the City Council designated appropriate units for certain represented employee classifications and confirmed the existing appropriate units for the remaining represented employee classifications within the classified service most recently when it adopted Resolution No. 2015-10 on March 11, 2015; and

**WHEREAS**, by its adoption of the 2015-2016 Memorandum of Understanding between the City of Bell and the Bell City Employees Association, the City Council has authorized the creation of the following represented positions within classified service: Assistant Planner and Associate Planner; and

**WHEREAS**, the City Council desires, through this resolution, to update the classifications of the represented employees within classified service to include the position Assistant Planner and Associate Planner and to rescind Resolution No. 2015-10.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BELL DOES HEREBY RESOLVE AS FOLLOWS:**

**SECTION 1.** Resolution No. 2015-10 is superseded and is hereby rescinded.




