

RESOLUTION NO. 2016 – 17

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BELL AUTHORIZING FY 2015-16 BUDGET AMENDMENTS TO TRANSFER \$309,381 FROM GAS TAX PRP FY2016 TO GAS TAX RESERVES, \$195,000 FROM PROP C RESERVES TO PROP C PRP FY2016, \$200,000 FROM MEASURE R PRP PHASE IV TO MEASURE R RESERVES, \$25,354 FROM CALRECYCLE RESERVES, AND \$19,300 FROM TDA PRP FY2016 TO TDA RESERVES

WHEREAS, on April 13, 2016, the Bell City Council approved the budget amendment to transfer \$309,381 from Gas Tax PRP FY2016 to Gas Tax Reserves, \$195,000 from Prop C Reserves to Prop C PRP FY2016, \$200,000 from Measure R PRP Phase IV to Measure R Reserves, \$25,354 from CalRecycle PRP FY2016 to CalRecycle Reserves, and \$19,300 from TDA PRP FY2016 to TDA Reserves; and

WHEREAS, the Proposition C Reserve Balance of the City has sufficient fund balance available to advance to the Proposition C PRP FY2016 Fund.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BELL DOES HEREBY:

Section1. Transfer Funds. Approve the transfer of Gas Tax PRP FY2016 to Gas Tax Reserves, Proposition C Reserves to Proposition C PRP FY2016, Measure R PRP Phase IV to Measure R Reserves, CalRecycle PRP FY2016 to CalRecycle Reserves, and TDA PRP FY2016 to TDA Reserves.

Section2. Budget Amendment. The City Council hereby approves amending the Fiscal Year 2015-16 budget by appropriating an amount of \$309,381 from Gas Tax PRP FY2016 to Gas Tax Reserves, \$195,000 from Prop C Reserves to Prop C PRP FY2016, \$200,000 from Measure R PRP Phase IV to Measure R Reserves, \$25,354 from CalRecycle PRP FY2016 to CalRecycle Reserves, and \$19,300 from TDA PRP FY2016 to TDA Reserves.


