

RESOLUTION No. 2012-66

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BELL, CALIFORNIA DESIGNATING THE FOLLOWING FULL-TIME AND PART-TIME OFFICERS AND EMPLOYEES OF THE CITY TO BE UNREPRESENTED EMPLOYEES, PURSUANT TO MUNICIPAL CODE SECTION 2.84.0630 (B), AND RESCINDING RESOLUTIONS NO. 2002-41, 2003-31, 2004-24, 2005-10, 2006-36, 2007-25, 2007-39, AND 2008-24.

WHEREAS, Section 2.84.030(B) of the Bell Municipal Code authorizes the City Council to designate by resolution officers and employee classifications who shall be unrepresented employees of the City;

WHEREAS, the City Council adopted Resolution No. 2002-41 on July 15, 2002, Resolution No. 2003-31 on June 30, 2003, Resolution No. 2004-24 on June 28, 2004, Resolution No. 2005-10 on May 2, 2005, Resolution No. 2006-36 on June 26, 2006, Resolution No. 2007-25 on May 7, 2007, Resolution No. 2007-39 on July 23, 2007, and Resolution No. 2008-24 on June 30, 2008, regarding the designation of certain employee classifications as unrepresented employees; and

WHEREAS, the City Council further desires to rescind Resolution Nos. 2002-41, 2003-31, 2004-24, 2005-10, 2006-36, 2007-25, 2007-39, and 2008-24.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF BELL DOES RESOLVE AS FOLLOWS:

SECTION 1. Resolution Nos. 2002-41, 2003-31, 2004-24, 2005-10, 2006-36, 2007-25, 2007-39, and 2008-24 are hereby rescinded.

SECTION 2. Pursuant to Bell Municipal Code Section 2.84.030(B), the following full-time officers and employees shall be designated unrepresented employees:




