

RESOLUTION NO 2016- 70

A RESOLUTION OF THE CITY COUNCIL OF CITY OF BELL AUTHORIZING THE CITY MANAGER TO AWARD ANAYA'S SERVICE CENTER A THREE-YEAR CONTRACT WITH AN ADDITIONAL TWO-YEAR EXTENSION OPTION FOR THE PURPOSE OF MAINTAINING THE CITIES VEHICLE FLEET AS PART OF REQUEST FOR PROPOSAL (RFP) BIDDING PROCESS.

WHEREAS, the City of Bell currently requires maintenance and other emergency repair service of its fleet of vehicles; and

WHEREAS, the City of Bell desires to contract with a qualified vendor to provide fleet maintenance and other emergency repairs and other necessary service for all the City's vehicles; and

WHEREAS, on July 22, 2016, the City advertised and mailed a Request For Proposal (RFP) to several qualified firms; including local businesses; and

WHEREAS, on August 5, 2016. The City received two (2) proposals, which were reviewed by staff pursuant to criteria outlined in the RFP, and


WHEREAS, the RFP allowed for the award of a single contract for routine scheduled maintenance and for emergency road repairs and other necessary service to ensure City vehicles are safe to operate; and

WHEREAS, staff has determined that Anaya's Service Center is the most qualified bidder to perform routine scheduled fleet maintenance and emergency road repairs determined necessary to ensure safe operation of vehicle; and


NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BELL DOES HEREBY:

Section 1. Authorize the City Manager to enter into a three-year, with a two-year option to extend the contract with the Anaya's Service Center for the purpose of maintaining the City vehicle fleet and provide routine scheduled maintenance and service to all City vehicles in the fleet in an amount not to exceed \$190,000.00 per year.




